Eligibility Requirements

This category of CREW Network membership is offered only to an individual currently enrolled full-time as an undergraduate student* at an accredited college, university or educational institution who is pursuing a professional degree that will enable them to secure a position in one of the qualified fields of commercial real estate, upon completion. All policies set by the CREW Network Council and Board of Directors regarding membership in CREW Network shall be administered in a non-discriminatory manner.

To qualify for membership as an individual Student-At-Large member:

- The individual shall demonstrate support for the CREW Network statement of purpose as set forth in the CREW Network Bylaws;
- The individual must be currently enrolled full-time as an undergraduate student, pursuing a degree in one or more of the qualified fields of commercial real estate; and
- The individual shall maintain the highest professional and ethical standards.
- Membership status and qualifications will be reviewed annually.

Benefits/Responsibilities of Membership

Student At-Large members will pay a discounted rate from those that are required for FULL members. Students will receive the monthly e-newsletter. They may attend the CREW Network convention at a deeply discounted student rate. Only student members are eligible to participate in CREW Network's eMentoring program and UCREW program offered at our annual convention. Student-At-Large members may participate on CREW Network committees, but will not be able to serve as a Delegate nor hold national office, nor will they be represented or have voting rights on the CREW Network Council. Student members will be notified via electronic mail of any CREW Network scholarships including the criteria and deadlines.

CREW Network will collect dues and member information directly from individual Student-At-Large members. It will be the responsibility of the individual Student-At-Large member to respond to requests for dues and information in a timely manner, and keep CREW Network apprised of any changes in status or information.

Application Fee and Dues

A non-refundable application fee of \$25.00 and a copy of your current transcript must accompany the Student-At-Large Membership Application. If approved, new Student-At-Large members will receive an invoice for CREW Network dues. Calendar year dues for 2008 and 2009 are half the regular member rate. (\$80)

**Because CREW Network membership dues are so reasonably priced, CREW Network is only able to offer the Student-At-Large membership discount to full-time undergraduate students to expose them to careers in commercial real estate.*
